



Twin Waters Golf Academy Membership Terms & Conditions

Acceptance of Membership. Acceptance of membership by the proprietor shall constitute a binding agreement between the proprietor and the member upon the terms and conditions of membership laid out below.

1. Assignment.

Membership of the Academy is personal and cannot be transferred to another individual.

2. Access. Membership entitles the member access to the Golf Academy during the hours below

Summer – 6.30am – 5.30pm (Monday – Sunday)

Winter - 6.30am – 5.00pm (Monday – Sunday)

- Scheduled classes and supervised training will operate between and beyond these times and may require booking.
- Opening hours may be changed by the proprietor – notice will be provided to all members in this instance.

3. Physical Condition of the member.

The member warrants and represents that he/she is in a physical condition that allows for safe engagement of physical exercise and such exercise would not be detrimental to his/her health and safety. Each member is required to complete Twin Waters Golf Academy Exercise Readiness Questionnaire.

4. Indemnity

Membership serves as a liability release, pursuant to which the member agrees to indemnify and hold Twin Waters Golf Academy and its proprietors harmless against any and all claims of loss, damage or injury without limitation.

5. Age.

Members under the age of 16 cannot enter or be left unattended unless supervised by an adult member or if attending an organised Academy activity

6. Member Conduct

- (a) Members must comply with the Academy dress code
- (b) Members must show consideration for other members and staff in and around the Academy
- (c) Members must not use abusive or bad language and may not use the facilities whilst under the influence of drugs or alcohol
- (d) Members must not bring non-members to the facility unless with prior agreement from Academy staff.

7. Termination of Membership

The membership is for an initial period of 1 month, the member can then cancel the membership at any point by giving (in writing) two week notice of termination. Termination within the initial period (1 month) will not result in a refund of membership payments.

8. Alterations or Variations to membership.

The proprietor reserves the right to increase the membership fees at any time. In such instances written notice will be provided to each member. Members who do not wish to accept an increase may submit a termination request which will be processed in accordance with membership conditions (6) and that member will not be subject to any such increase in membership fees.

9. Membership Fees.

1 x Initial payment of \$100 for the first month, this includes:-

- Set up and administration of Membership
- Initial TPI and Health & Wellbeing Assessment & Personal Exercise Program based upon goals and results
- Access to the Academy and membership benefits below

Thereafter payments of \$15 per week, paid every 4 weeks in advance

- 1 Medium sized bucket of range ball per week (unused vouchers cannot be carried over to following month)
- Access to Golf Academy , including supervised training and golf training aids
- Monthly Clinic with Anthony Gilligan (voucher must be used within membership month, cannot be carried forward)
- Monthly Members Challenge / Focus
- 30% Off all Fitness Classes
